

Privacy Policy

We value your privacy and the trust you place in us. This privacy policy explains how SCOFF (South Canterbury Outstanding Food Festival) www.scoffsc.nz website administered by Venture Timaru Limited collect and utilize personal information. By accessing this website, you agree to the policy outlined below.

Use of personal information

Personal information collected via the SCOFF website can include, but is not limited to: name, email address, phone number, address, and date of birth

How personal information is collected

- Registering for SCOFF communications.
- Participating in a competition, giveaway or survey administered by the Festival.
- Submitting details where contact tracing is required.

How this information is used

- Communicating SCOFF news, information about upcoming events and promotions.
- Contact tracing as required by the government.
- Communicating changes about the event/ restaurant which you intended to attend.
- Survey information is used to report to our funders, sponsors, and board and to help plan future festivals. In the case of surveys, only aggregate information is reported. Information that would personally identify an individual is never shared.

Non-Identifying information

Non-identifying information can include but is not limited to: website and page visits, likes & posts shared and

How non-identifying information is collected

- Visiting the SCOFF website or the Facebook page.
- Sharing the posts linked to the website
- Promoting information posted on the website

How this information is used

We use non-identifying and statistical information to better design our website, plan future festivals, and gauge audience engagement. Occasionally we will reveal statistical information about our site, such as number of visitors, pages viewed, etc., but we will never reference visitors' names or other personally identifiable information.

Storage of personal information

To prevent unauthorised access, maintain data accuracy, and ensure the correct use of information, we have put in place appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect. We do not share personally identifiable information with outside parties except to the extent required by law or necessary to the safe operation of the Festival. Your details are never sold, rented, or viewed by any third-



party organisation. Your information is never used for purposes other than those for which it was originally collected without also providing you an opportunity to opt-out or otherwise prohibit such unrelated uses.

Photography/ Filming for the Festival

By attending the festival, you consent to Venture Timaru Ltd or third parties appointed by Venture Timaru Ltd to photograph and film you. Venture Timaru Limited or third parties appointed by Venture Timaru Ltd can broadcast, publish, license and use any photographs, film, recordings and images of you without compensation. Venture Timaru Ltd, the third parties, and licensees are not liable to you in any way for its use.

Third Party Services

We use third party services, such as Weebly Analytics to report website usage. We also have links of other websites linked to SCOFF website to be able showcase their services for the SCOFF. Venture Timaru Ltd is not responsible for the privacy practices of these services, or for the content and polices of other organisations linked via our website. Please visit the privacy policies of these third-party sites in order to understand their privacy and data collection practices.

Links to social networking services

We use social networking services to communicate with the public about SCOFF's updates and work. When users interact with Venture Timaru via these services, the social networking services may collect users' personal information for their own purposes. Such services have their own privacy policies which users are advised to read.

Your rights and choices

- You have the right to request access to any personal information that SCOFF website holds about you.
- If such information is inaccurate, you can request that Venture Timaru correct it.
- Users can also ask to be removed from any of content on SCOFF website or social media platforms such as SCOFF Facebook page or SCOFF Instagram page

In addition to the rights listed above, if you are in the European Economic Area you also have rights to:

- Know what personal information SCOFF website holds about you, and to make sure its correct. However,
 while the individuals have a right to ask for access to their personal information, Venture Timaru can
 sometimes refuse such requests. This will involve giving the person access would endanger someone's
 safety or would involve an unwarranted breach of someone else's privacy.
- Request a copy of your personal information or ask Venture Timaru to restrict processing it or delete it
- Object to continued processing of your personal information and ask Venture Timaru to delete all personal information held about you
- Complain to your local information protection authority about how Venture Timaru is processing your personal information.
